

Conditions of Participation in “HSM Voucher Promotion” for the United Kingdom

1. Voucher Promotion

The voucher promotion is being run by HSM GmbH + Co. KG at the promotional site www.hsm.eu/voucher-promotion. The company will hereinafter be referred to as HSM. HSM offers shopping vouchers from attractive shopping partners in participating European countries as a free add-on to selected promotion products. By participating in the voucher promotion, the Participant accepts and confirms reading and understanding the following Conditions of Participation.

2. Participation

All purchasers of an HSM product who have purchased one of the promotional models at a participating HSM distributor between 01 January 2021 and 31 December 2021, have the opportunity to participate in the voucher promotion by filling out the form on HSM's promotional page. Within the promotion period the number of vouchers is limited to a total of five vouchers per buyer or company.

3. Promotional Products

The Participant in the voucher promotion receives a Love2Shop (UK) gift voucher after purchasing an HSM document shredder promotional product.

5. Prerequisite for Participation: Proof of Purchase

The Participant's proof of purchase from the HSM distributor and the product serial number serves as the basis for participation. Participation in the voucher promotion is free of charge and voluntary.

6. Prerequisite for Participation: Person and Domicile

Exclusively natural persons who have reached full legal age and companies with their domicile in the United Kingdom are eligible to participate. HSM employees and their relatives, companies and employees of participating HSM distributors as well as all commercial resellers are excluded from participation in the voucher promotion. Please note that before redeeming the voucher, you may need to obtain approval from your employer to comply with any company policies.

7. Prerequisite for Participation: Contact Details

Participation in the voucher promotion requires the full, and correct completion of the form on the promotional page <http://www.hsm.eu/voucher-promotion> and a valid proof of purchase. Every Participant who submits the completed participation form in full within the promotional period to HSM shall partake in the voucher promotion. The information given by the Participant on the form is considered to be valid.

8. Correctness of the Contact Details

HSM is not obliged to search for the correct information (e.g. names, addresses). In the event that the contact information given is incorrect, HSM reserves the right not to deliver the voucher.

9. Promotion Exclusion

HSM reserves the right to exclude participants from the voucher promotion at any time for good cause. Good causes are particularly, but not exclusively, if the Conditions for Participation are violated, where there is attempted manipulation of the voucher promotion, attempted disruption to or influence on the proper execution of the promotion, as well as any threat to or harassment of HSM employees or other participants.

10. Retrospective Promotion Exclusion

If the prerequisites for exclusion are met, vouchers can later be denied and reclaimed. The given participation deadline is applicable to the voucher promotion. The judges' decision is final. In particular, there is no legal claim to participation in the voucher promotion.

11. Participation Deadline

The deadline for participation is 31/12/2021 at 23:59.

12. Premature Promotion End

HSM reserves the right to suspend or end the voucher promotion at any time without advance notice and without notification of cause. This is particularly applicable where there is force majeure or in the event that the voucher promotion cannot be carried out or resumed due to organisational, technical or legal reasons.

13. Transfer of Voucher

After receipt of the e-mail containing the contact details and the proof of purchase, the participant will be contacted in writing by e-mail and will receive the shopping voucher of the respective voucher operator by postal mail.

14. Redemption Prerequisite

To redeem the voucher, it may be necessary to register with the respective voucher operator.

15. Voucher Redemption

The voucher code can only be redeemed from the respective voucher operator.

16. Balance

The value of the voucher will be credited to your respective voucher operator's account after redemption. The balance will be automatically deducted from the total amount of a purchase on the account. A cash payment is excluded.

17. Balance Maturity

The credit expires after the respective end date printed on the voucher or is based on the period specified in the terms and conditions of the respective voucher operator.

18. GTC of the respective voucher operator

19. Assignment and Transfer to Third Parties

Assignment and transfer to third parties, for whatever reasons, is not possible and is explicitly excluded.

20. Liability

HSM is not liable for possible manipulations of or interferences with the course of the voucher promotion. To the extent permitted by law, HSM excludes any liability for claims in conjunction with the voucher promotion made by those participating in the promotion.

21. Invalidity of Individual Conditions of Participation

Should individual conditions of these Conditions of Participation be or become invalid, the legal validity of the remaining conditions shall not be affected. An appropriate provision shall come into force for the invalid condition which best corresponds to the original purpose of the invalid condition.
